

**RESOLUTION NO. 2017-10**

**RESOLUTION OF THE TOWN COUNCIL OF MARKLE, INDIANA ADOPTING A  
BUILDING PERMIT FEE RESOLUTION.**

**WHEREAS**, it is necessary to review and inspect construction and development activities within the jurisdiction of the Huntington Countywide Department of Community Development; and

**WHEREAS**, the Huntington Countywide Department of Community Development has requested that a new fee schedule be adopted for the permitting and inspection services provided by the Department in order to be consistent with current costs and services provided; and

**WHEREAS**, the Town Council of Markle, Indiana deem it to be reasonable, appropriate, and in the best interests for the public health, safety and general welfare of the citizens of the Town of Markle to adopt a resolution outlining building permit fees and services;

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of Markle, Indiana that Ordinance 2005-04 adopted May 18, 2005 is hereby repealed and replaced by the following:


